From September 2017 to December 2020, Mr. Papadopoulo was Chairman and CEO of Arch Worldwide Insurance Group and CUO for Property and Casualty Operations. From July 2014 to September 2017, Mr. Papadopoulo was Chairman and CEO of Arch Reinsurance Group at Arch Capital Group Ltd. He joined Arch Re Bermuda in December 2001, where he held a variety of underwriting roles. Prior to joining Arch, he held various positions at Sorema N.A. Reinsurance Group, a U.S. subsidiary of Groupama, and he was also an insurance examiner with the Ministry of Finance, Insurance Department, in France. Mr. Papadopoulo currently serves on the board of directors of Coface SA. Mr. Papadopoulo graduated from École Polytechnique in France and École Nationale de la Statistique et de l'Administration Economique in France with a master's degree in statistics. He is also a Member of the International Actuarial Association and a Fellow at the French Actuarial Society.

Christopher J. Swift is chairman and CEO of The Hartford, a national leader in property and casualty insurance (P&C), group benefits and mutual funds, founded in 1810.



Swift was the driving force in the company's transformation, resulting in a more focused, disciplined leader in property and casualty, group benefits and mutual funds. Named CEO in 2014, he expanded the company's capabilities and geographic reach through organic growth and strategic investments, including the purchase of Aetna's U.S. group life and disability business in 2017 and The Navigators Group, Inc., a specialty lines property and casualty business, in 2019. He also completed the company's exit from the run-off life and annuity business, providing greater financial flexibility and improving The Hartford's return on equity and earnings growth profile.

The Hartford ranks highest among insurance companies on the 2024 JUST 100 list by independent research nonprofit JUST Capital and CNBC, marking the sixth consecutive year on the list. He has appeared on CNBC and Bloomberg on several occasions.

Swift joined The Hartford in March 2010 as executive vice president and chief financial officer. In that position, he played a central role in the company's strategic transformation to focus on the property and casualty, group benefits and mutual funds businesses. He was also instrumental in strengthening the balance sheet through the sale of its individual life and retirement plans businesses and reducing debt.

Previously, Swift held senior leadership and finance roles at American International Group (AIG). He began his career as a certified public accountant at KPMG LLP focused on financial services and was eventually appointed head of the Global Insurance Industry Practice.

He earned a bachelor's degree in accounting from Marquette University, where he is also a trustee.

BUSINESS HISTORY - Mr. Button is president and chief executive officer of Pacific Life. He is the 15th chief executive officer in the company's nearly 160-year history.

Mr. Button joined Pacific Life in 2017 as executive vice president and chief financial officer (CFO) where he was responsible for the development and implementation of the company's corporate and financial strategies, as well as the corporate finance, internal audit, enterprise risk management, and corporate development functions. Additionally, Mr. Button oversaw Pacific Life's investment organization, which manages the general account assets and was responsible for Pacific Life's institutional business. On April 1, 2022, Mr. Button became Pacific Life's president and chief executive officer.

Prior to joining Pacific Life, Mr. Button was with Aegon for 17 years where he most recently served as CFO and member of the Executive Board of Aegon N.V. He also previously served as head of Aegon N.V.'s corporate financial center, CFO of Aegon's U.S. subsidiary Transamerica, and as chairman for the company's Canadian operations.

Mr. Button began his career at Mutual Life Insurance Co. of Canada and is a fellow of the Society of Actuaries (FSA), a fellow of the Canadian Institute of Actuaries (FCIA), a member of the American Academy of Actuaries (MAAA), and a former member of the Board of Directors of the American Chamber of Commerce in the Netherlands.

Khalaf joined MetLife in 2010 as chief executive officer of the Middle East, Africa and South Asia (MEASA) region when the company acquired Alico from AIG. In 2011, he joined MetLife's Executive Leadership Team when he was named president of the Europe, Middle East and Africa (EMEA) region with responsibility for individual and group insurance businesses sold through agent, broker, bank and direct channels in more than 25 markets. In 2017, he added responsibility for the company's U.S. businesses — Group Benefits, Retirement & Income Solutions and Property & Casualty — and for Global Employee Benefits, a horizontal business unit dedicated to growing employee benefits in approximately 40 markets.

In 2019, Khalaf launched MetLife's Next Horizon strategy, which is grounded in the company's purpose – "Always with you, building a more confident future." 


